

**SOUTHKENT SPORTSMEN’S CLUB  
MEMBER RENEWAL LIABILITY WAIVER AND RELEASE**

**YOU MUST READ THIS LIABILITY WAIVER AND RELEASE BEFORE SIGNING IT. IF  
YOU HAVE ANY QUESTIONS, PLEASE ASK THE CLUB PRESIDENT.**

I desire renewal membership in Southkent Sportsmen’s Club (the “Club”). I understand that, among the other requirements set forth in the Club Bylaws, I am required to read and sign this liability waiver to RENEW my membership in “the Club” for the **2021** calendar year.

Accordingly, I acknowledge, understand, and agree with all of the following:

1. I am allowed to legally purchase and possess firearms under Michigan and Federal law; **Initial**\_\_\_\_\_
2. Use of Club facilities generally involves the use of one or more firearms. Firearms are deadly weapons. The risk of injury to myself and others from use of firearms at Club facilities is significant and includes, but is not limited to, serious injury, permanent paralysis and death. Although particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury always exists; **Initial**\_\_\_\_\_
3. I have sole responsibility for my actions as a member with access to and use of Club facilities and for any and all individuals who have access to the Club under my membership or are guests of mine at the Club. My use of Club facilities is completely voluntary, as is use by my guests and anyone who has access to the Club under my membership. I, my guests, and those who have access to the Club under my membership voluntarily choose to use Club facilities, including use of firearm(s) at Club facilities, notwithstanding the risk involved. I was not pressured in any way to become a member of the Club or to use Club facilities. **Initial**\_\_\_\_\_
4. I knowingly and willingly assume all risks of my use of Club facilities, known and unknown, even if the risks arise from the negligence of the Club, its Directors, Members, or others, and I assume full responsibility for my use of Club facilities and the use of Club facilities by any and all guests of mine; **Initial**\_\_\_\_\_
5. I willingly agree to comply with the rules applicable to use of the Club facilities and require all guests of mine to comply with Club rules. If I or a guest of mine observe any unusual significant hazard before, during or after use of Club facilities, I will immediately bring such to the attention of the Club President; **Initial**\_\_\_\_\_
6. I understand that the Club is not responsible for the actions of its Board, its officers, its Members, guests of its Members, or anyone else. Any unsafe, negligent or otherwise harmful actions are solely the actions of the particular person and are not condoned or in any way attributed to the Club; **Initial**\_\_\_\_\_
7. I, for myself and on behalf of my heirs, successors, assigns, personal representatives, next of kin, and guests, hereby release, indemnify and hold harmless the Club, its Board of Directors, officers, officials, members, agents, employees, and guests with respect to any and all injury, disability, death or loss or damage to person or property, whether arising from the negligence of the any of the above or otherwise, to the fullest extent permitted by Michigan law; **Initial**\_\_\_\_\_
8. I certify that I am 18 years of age or older. **Initial**\_\_\_\_\_

“Club facilities” means all grounds, buildings or other structures owned or operated by the Club.

I have read this release of liability and assumption of risk agreement, fully understand the terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any coercion or outside influence.
